CONVENTION STATUTORY AUTHORITY

116.02(1)(c)

The state superintendent shall cause to convene annually on the day that the board of control holds its annual organizational meeting under par. (a), a convention composed of the representative from each school board in the agency. The secretary to the board of control of the agency shall act as nonvoting secretary to the convention. In the secretary's absence, the convention shall appoint an acting secretary from among the representatives to the convention. Upon the convening of the convention the representatives from all school boards within each union high school district territory meeting separately, shall elect a single representative to represent the territory in the election of members of the board of control. After the meeting for election of a single representative from each union high school district territory, the convention shall elect the members of the board of control, in accordance with the plan of representation for the agency adopted under par. (d). The members of the board of control shall be elected for staggered three-year terms and shall be chosen from among the representatives elected to represent each union high school district territory and the representatives appointed by the school boards of districts operating both elementary and high school grades. The convention may direct the board of control to determine a different date for the annual organizational meeting.

STATUTORY REFERENCES

Section 9145 1995 Wisconsin Act 27 and Chapter 116

BOARD OF CONTROL - PLAN OF REPRESENTATION

Annual conventions held after June 12, 1996, shall adhere to the initial plan of representation adopted on June 12, 1996, unless a petition proposing a different plan of representation, signed by at least 25% of the school board presidents of school districts within the agency, is filed with the chairperson of the board of control at least 30 days prior to the convention. Within 5 days after receipt of the petition, the chairperson of the board of control shall notify the school board of each school district within the agency, in writing, of the petition and of the proposed plan of representation. If the convention approves the proposed plan of representation, it shall be in effect for the election of members of the board of control at that convention and shall remain in effect at subsequent annual conventions until further modified under this bylaw.

Annual Convention - Meeting Date

The annual convention of 1996 determined the first Monday of August for future conventions.

The Lakeland Area delegates that were present met briefly to determine a voting delegate from the group. Sarah Kemp (LUHS) served as the voting delegate.

Tom Rulseh nominated Andy Merry to serve as the Convention Chairperson. Dan Thompson seconded the nomination. All present voted aye. Motion carried.

Motion by Dan Thompson, second by Helen Ackermann to adopt the Roberts Rules of Order for the Convention. All present voted aye. Motion carried.

The August 3, 2015 Annual Convention minutes were presented. A motion was made by Dan Thompson and seconded by Helen Ackermann to accept the minutes as presented. All present voted aye. Motion carried.

Election of Board of Control members was the next order of business. The election plan was reviewed and vacancies for the various class seats on the Board of Control were announced. Dr. Heldt stated that there were four seats available (one Small, two Medium and one Large).

Those eligible for the Small seat were asked to indicate their desire to remain on the ballot or decline. Declining: Tess Kaiser, Ann Mas. Sherry Bierman was not present and therefore removed from the ballot. Remaining on the ballot: Scott Everson. Helen Palmquist made a motion to cast a unanimous ballot for Scott Everson to represent the Small category. Motion was seconded by Duane Frey. All delegates present voted aye. Motion carried.

Those eligible for the two Medium seats were asked to indicate their desire to remain on the ballot or decline. Declining: Cory Tomczyk. Beth Seubert was not present and therefore removed from the ballot. Remaining on the ballot: Dan Thompson and Tom Rulseh. Cory Tomczyk made a motion to cast a unanimous ballot for Dan Thompson and Tom Rulseh to represent the Medium category. Motion was seconded by Helen Ackermann. All delegates present voted aye. Motion carried.

Those eligible for the Large seat were asked to indicate their desire to remain on the ballot or decline. Declining: Sarah Kemp, Jen Seliger. Remaining on the ballot: Theresa Miles. Motion by Cory Tomczyk to cast a unanimous ballot for Theresa Miles. Second by Kevin Zubke. All present voted aye. Motion carried.

Prior to election, candidates must declare intention of which seat they will seek, i.e., class representation, or at large.

Large School Class	Three (3) three-year terms
Medium School Class	Three (3) three-year terms
Small School Class	Three (3) three-year terms
At Large Class	Two (2) three-year terms

Membership on a board of control is terminated:

- a. Upon the incumbent's position as a school board member becoming vacant under s.17.03.
- b. Upon the naming of a successor to his/her position on the board of control.
- c. Upon his/her resignation submitted in writing to the president or secretary of the board of control.

IF A VACANCY OCCURS UNDER SUB.(a) OR (c) ABOVE, THE PRESIDENT OR SECRETARY OF THE BOARD OF CONTROL SHALL REQUEST THE SCHOOL BOARD FROM WHICH THE MEMBER CAME TO APPOINT ONE OF ITS MEMBERS TO THE VACANCY. SUCH APPOINTMENTS SHALL APPEAR UPON THE SCHOOL BOARD MINUTES AND BE CERTIFIED BY THE SCHOOL DISTRICT CLERK TO THE BOARD OF CONTROL.

VACANCIES ON THE BOARD OF CONTROL WILL BE FILLED BY THE LOCAL BOARD OF EDUCATION TO COMPLETE THE TERM OF OFFICE. IF A LOCAL BOARD OF EDUCATION DOES NOT CHOOSE TO FILL A VACANT SEAT, THEN THE NEXT CESA ANNUAL CONVENTION WILL ELECT A SCHOOL DISTRICT REPLACEMENT FROM THE APPROPRIATE CATEGORY OF SCHOOL SIZE.

ANY MEMBER OF THE BOARD OF CONTROL IS ELIGIBLE FOR RE-ELECTION AT THE END OF HIS/HER TERM.
